COMPANY PROFILE

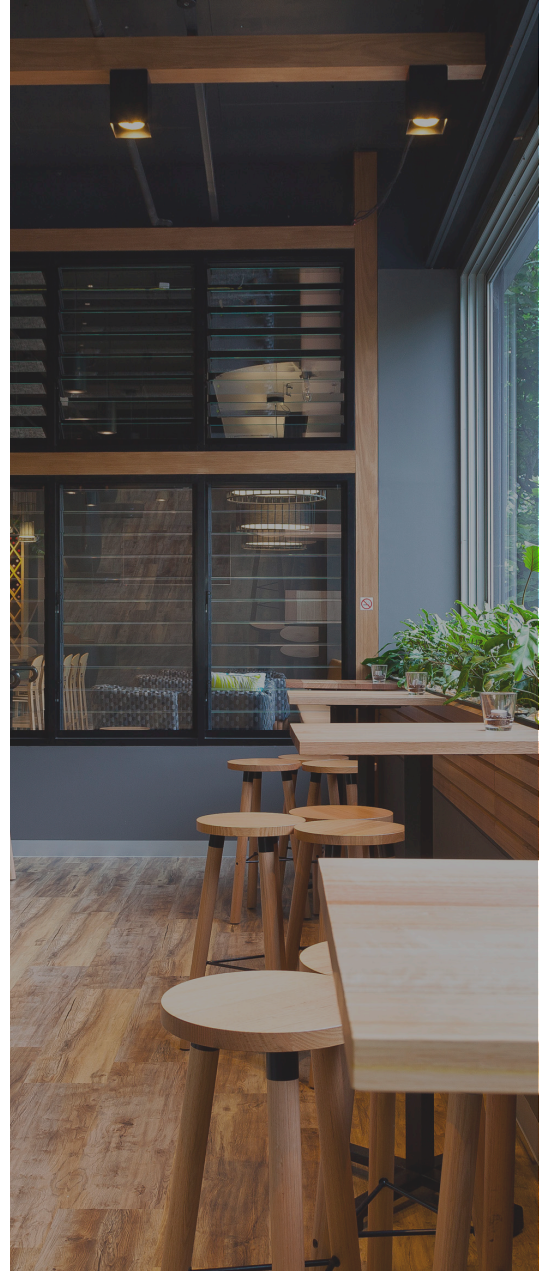
BRD Group is a multi-award-winning Building and Interior Design practice committed to providing the highest quality service.

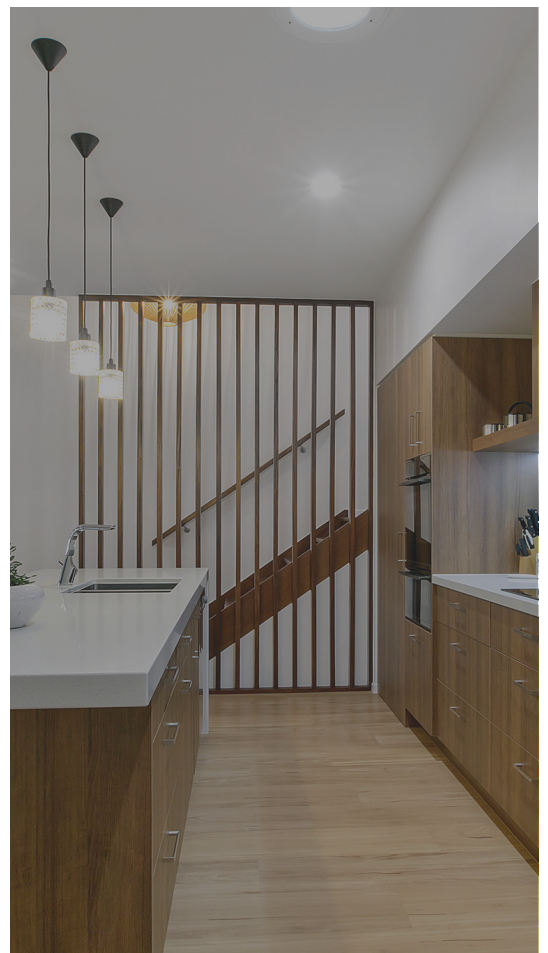
